- To provide the Streetsville BIA with proof of sufficient liability insurance by **Friday, October 25<sup>th</sup>** (*Insurance can be obtained from the City of Mississauga facilitated by the SBLA*)
- If selling food or beverages, to provide proof of the necessary health permits and completed food vendor health forms from the Region of Peel
